Gender Equality Plan

Summary

Prepared by Marina Odalovic (Serbia), responsible for the Gender Equality area in BetterCare.

As part of BetterCare's commitment to strengthening gender awareness and improving the integration of gender perspectives across all its activities, a comprehensive analysis of gender balance was conducted to ensure equitable participation, fair access to leadership roles, and equal opportunities for young researchers and participants from Inclusiveness Target Countries (ITC).

Gender balance

Among participants who self-identified their gender, women represent the majority (115), followed by men (59). Two individuals identified with another gender, and one preferred not to say.



Gender Equality Plan

Leadership positions

Leadership roles reflect this balance, with 34 women and 19 men in leadership positions. No participants identifying as non-binary or other categories hold leadership roles, indicating a positive trend toward gender-balanced governance.

Young participants (ECI)

Early Career Investigators follow the same pattern, with 46 women and 19 men, suggesting that younger cohorts within BetterCare continue to be predominantly female.

ITC participation

Participation from ITC countries includes 68 women, 33 men, and 1 person who preferred not to disclose gender.

Conclusions

Overall, the analysis shows a strong and consistent female representation across participation, leadership, and early-career involvement in BetterCare, reflecting a solid foundation for gender balance within the Action.

These results highlight positive progress and reinforce our commitment to fostering equality, inclusiveness, and fair opportunities for all members.

BetterCare will continue to monitor gender indicators, promote balanced participation, and further strengthen gender-sensitive practices throughout the duration of the Action.


The Bettercare Podcast Series offers a space for reflection and dialogue on key challenges in home healthcare, patient safety, and the support of informal caregivers.

Eurocarers Research Working Group (ERWG) Vilnius Meeting 2025

9th and 10th October - Presentation by Nida Abed (University Miguel Hernández, Spain): "BetterCare COST Action: an overview"

An important meeting was held in Vilnius, co-organised by Eurocarers with the Lithuanian Centre for Social Sciences (Day 1) and the Lithuanian Academy of Sciences (Day2).

The focus covered the ethics of involving carers organisations in research, advances in support solutions, carers wellbeing, and improving care outcomes. The meeting brought together researchers and organisations from 15 countries, fostering collaboration between research, policy, and practice in informal care.



External activities

Patient Safety Conference 2025

The Patient Safety Conference 2025, held under the theme "Rethinking patient safety: Evolving roles and responsibilities in a changing healthcare landscape," (October 24th, 2025), gathered international experts to explore new paradigms for ensuring safe, high-quality care across diverse health settings. Discussions focused on the growing complexity of healthcare delivery, the expansion of home-based care, and the evolving responsibilities of healthcare professionals, patients, and caregivers in maintaining safety and continuity of care.

BetterCare (CA22152) contributed to the event by sharing insights from its European network on medication safety in homecare and integrated care systems. Its participation emphasized the importance of collaboration, evidence-based policy, and digital innovation to support safe medication practices beyond hospital environments. The Action's perspective reinforced the need to bridge clinical, social, and patient-centered approaches to achieve sustainable patient safety across all levels of care.

External activities

The 7th Global Ministerial Summit on Patient Safety 2025

The 7th Global Ministerial Summit on Patient Safety, held in Manila, Philippines on 3–4 April 2025, was organized by the Philippine Department of Health with the support of the World Health Organization (WHO). Under the theme “Weaving Strengths for the Future of Patient Safety Throughout the Health-care Continuum,” the event gathered delegates from 64 countries, experts, professionals, and patient representatives to address key implementation gaps identified in the Global Patient Safety Report 2024. Discussions emphasized accelerating progress on the Global Patient Safety Action Plan 2021–2030, with WHO Director-General Dr. Tedros reaffirming that patient safety must be a non-negotiable priority in every health system.

The Summit concluded with the adoption of the Mandaluyong Declaration, which calls for renewed urgency and global commitment to make patient safety a universal imperative and a foundation of resilient, people-centred, and equitable health systems. Continuing a series that began in London in 2016, the Manila Summit built on previous milestones to strengthen political commitment and promote collaboration, learning, and innovation. It reaffirmed the importance of translating global policy into concrete action to eliminate preventable harm and improve health outcomes worldwide.
