A text like that The Declaration represents an important outcome of our collective work and reflects a broad, multi-stakeholder consensus. Its development involved representatives from a diverse range of organisations and sectors, including associations representing informal caregivers, health and social care professionals, academic and research institutions, public authorities, ministries, national agencies, international organisations, and other key stakeholders with expertise in patient safety, home care, long-term care, and integrated care. This diversity of perspectives strengthens the relevance and legitimacy of the Declaration and reinforces its potential to inform policy, organisational practice, and future initiatives across Europe.
